## Hazards for humans and the environment



Contains propan-2-ol (Isopropyl Alcohol).

Signal word: Danger.

H225 - Highly flammable liquid and vapour. Hazard statements: H336 - May cause drowsiness or dizziness

H319 - Causes serious eye irritation.

#### Prevention and conduct



The following information applies for the uses indicated in subsection 1.2 of the Safety Data Sheet. If available, please refer to the product information sheet for application and handling instructions. Normal use conditions are assumed for this section.

Recommended safety measures for handling the undiluted product:

Appropriate engineering controls: Provide a good standard of general ventilation.

Appropriate organisational controls:

Avoid direct contact and/or splashes where possible. Train personnel. Personal protective equipment

Safety glasses are not normally required. However, their use is recommended in those cases where Eye / face protection:

splashes may occur when handling the product (EN 166).

Rinse and dry hands after use. For prolonged contact protection for the skin may be necessary. Hand protection:

Body protection: No special requirements under normal use conditions. Respiratory protection: Respiratory protection is not normally required. However, inhalation of vapour, spray, gas or aerosols

should be avoided.

Carbon dioxide. Dry powder. Water spray jet. Fight larger fires with water spray jet or alcohol-resistant

Do not allow to enter drainage system, surface or ground water. Dilute with plenty of water.

Absorb with liquid-binding material (sand, diatomite, universal binders, sawdust).

### First aid measures



Inhalation:

Remove person to fresh air and keep comfortable for breathing. Call a POISON CENTRE, doctor or physician if you feel unwell.

Skin contact:

Wash skin with plenty of lukewarm, gently flowing water. Take off immediately all contaminated clothing

Eye contact: Ingestion:

and wash it before re-use. If skin irritation occurs: Get medical advice or attention.

Hold eyelids apart and flush eyes with plenty of lukewarm water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If irritation occurs and persists, get medical attention. Rinse mouth. Immediately drink 1 glass of water. Never give anything by mouth to an unconscious person. Get medical attention or advice if you feel unwell.
