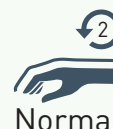

Product Description

Stokolan® Sensitive PURE is a white soft cream of the emulsion type oil-in-water (O/W). It does not contain preservatives, colouring agents and perfume.

The skin compatibility of Stokolan® Sensitive PURE was carefully tested under laboratory conditions and medical guidance on volunteers with a damaged skin barrier. In these tests, as well as in practical use, Stokolan® Sensitive PURE has proven to have very good skin compatibility properties.
